Notably, larger players in the life and annuity space, have demonstrated confidence in the jurisdiction by relocating or establishing operations there.

With its political stability, robust judicial system, tax neutrality, proximity and connectivity to the U.S. and a modern and reliable communications infrastructure, the Cayman Islands provides an ideal operating base for the growing number of insurance and reinsurance structures.

For those requiring on-the-ground presence, Cayman provides attractive lifestyle options, including long-term work permits and property ownership for expatriates. Additionally, CIMA's efficient approval process, typically completed within 6 to 8 weeks, offers commercial certainty for groups with transaction deadlines.

Cayman's stability in financial, political, and economic spheres, along with its stance on global minimum tax, further enhances its appeal as a premier jurisdiction for establishing reinsurance structures and the wider insurance market.

Recent growth

CIMA’s recent release of regulatory policies for licensing Class D reinsurers suggests continued growth in this sector. The choice of jurisdiction for a new reinsurer depends on several factors, including client goals, investor interests, and regulatory requirements. Cayman offers advantages such as flexibility in capital and accounting models, as well as no initial presence requirement for certain license classes.

At the ReConnect reinsurance conference held in Grand Cayman in April 2024, the Cayman Islands was hailed as one of the fastest growing reinsurance domiciles in the world with this being mainly attributed to the quality of life available in these Islands together with the support from the Cayman regulators who will be able to assist companies, despite the technological advancements in the insurance industry driven by artificial intelligence.
