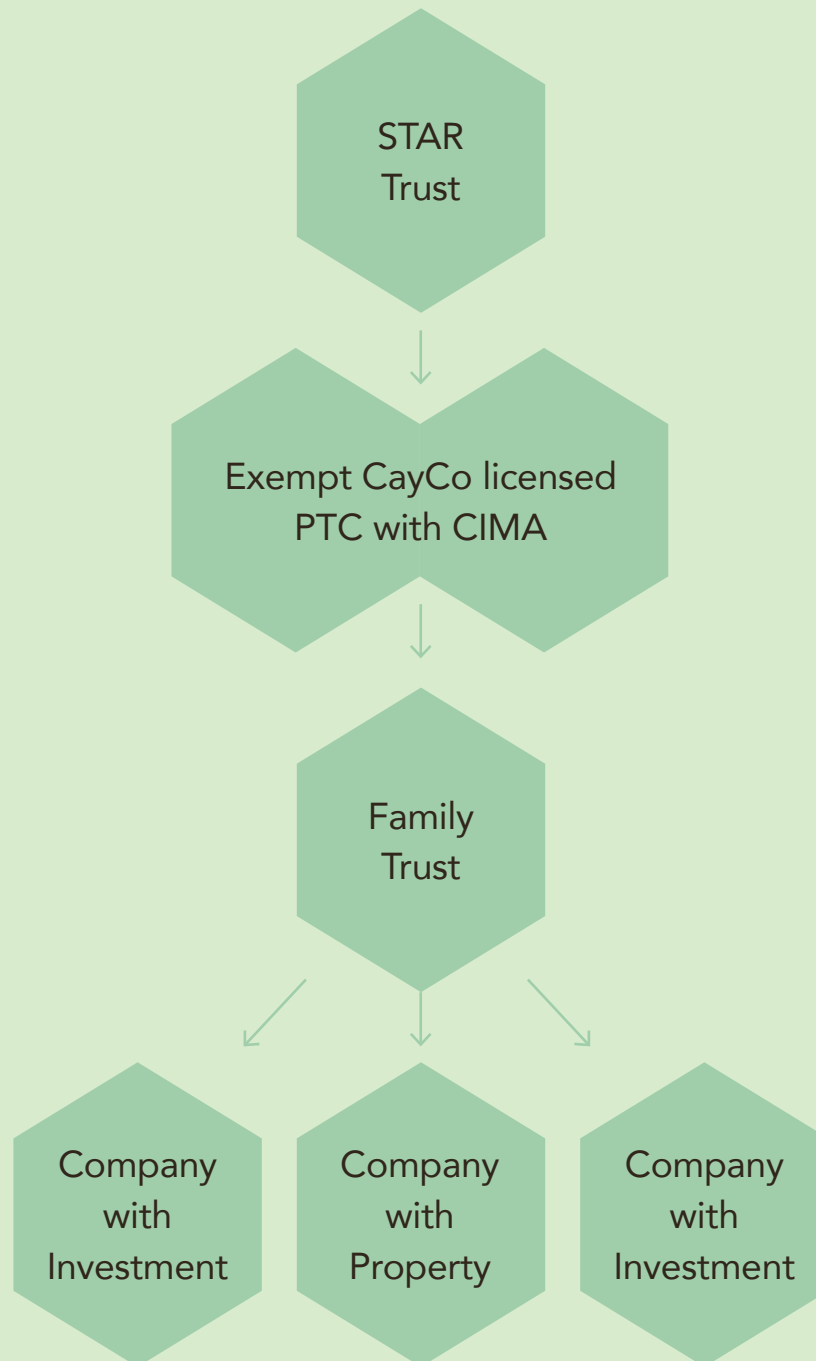
Trust management and trustee services

- serving as enforcer to STAR trusts:
 - FundBank can serve as an independent enforcer to the trust in order to further enhance corporate governance.
- providing industry professionals with the required experience to serve on boards of PTCs that, in turn, serve as trustee to charitable or private trusts.

Foundation companies in private wealth structures

The most recent trend is the use of a foundation company for the family office.

There are many ways for a foundation company to be utilized for private wealth management and structuring. The hallmark of a foundation company is leveraging the similar advantages of a traditional private trust while incorporating the benefits of a company structure. Moreover, the foundation company serves as a compelling alternative to succession planning, philanthropic endeavors, oversight or enforcement roles within a trust, and establishment of a private trust company. Equally, it serves as a contemporary, flexible substitute for a civil law foundation. In lieu of the complexity of a licensed trust company holding shares in a PTC, with the PTC concurrently acting as trustee of a discretionary trust, a singular foundation company can maximize efficiencies and minimize costs.

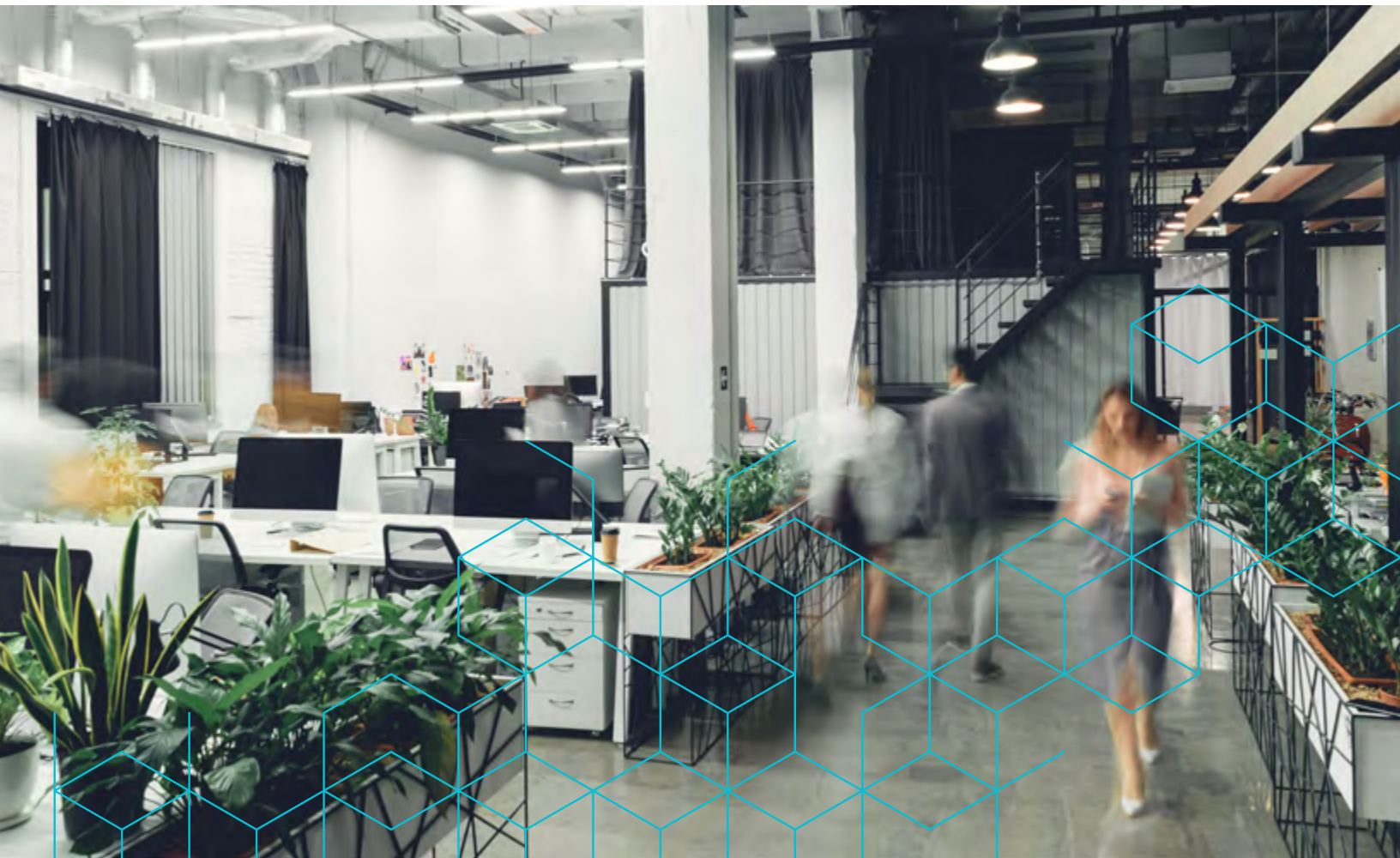

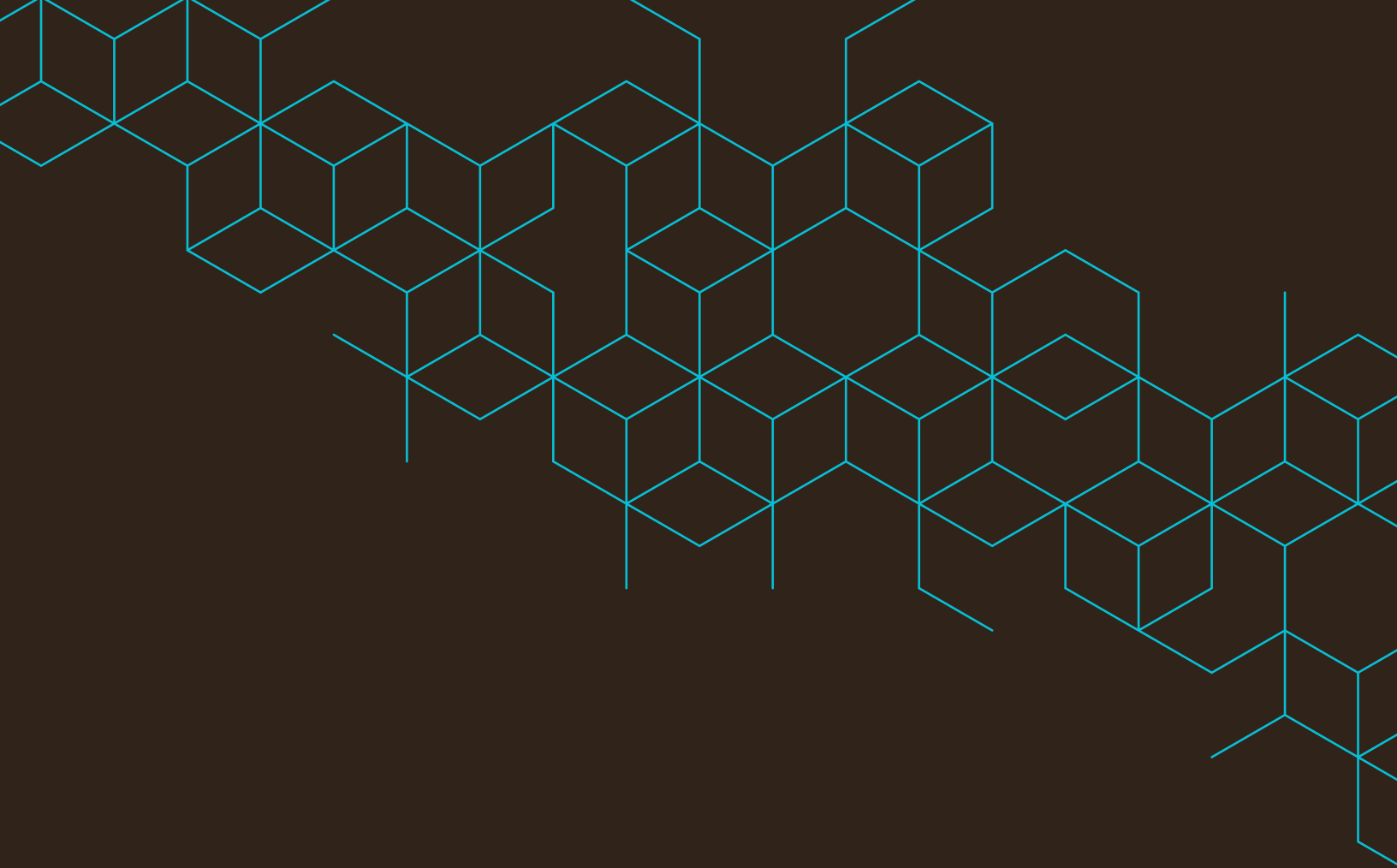
